DEED TO Geo. Hairston Jr

THE STATE OF MISSISSIPPI,

This Indenture, Made the 24th

day of July A.D. 1873, between George Hairston of the first part, and Geo. Hairston Jr of the second part, WITNESSETH: That the said part y of the first part, for and in consideration of the sum of thirty three Dollars, to him in hand paid by the said part y of the second part, the receipt whereof is acknowledged, hath granted, bargained, sold and conveyed, and by these presents doth grant, bargain, sell and convey to part y of the second part, his heirs and assigns, that certain tract or parcel of Land situated in the County of Lowndes and State of Mississippi, known and described as follows:

beginning at the N.W. corner of the E. 1/2 of the S.W. 1/4 of section 17 & running south 80 chains thence east 16 chains & 76 links thence north 80 chains thence west 16 chains & 76 links to the beginning to contain one hundred & thirty three acres more or less situated & lying in sections 17 & 20 Township 17 R. 17 east

together with appurtenances to said premises belonging, and all estate, title and interest, both at law and in equity, of the part y of the first part in the same; to have and to hold the said granted premises, with the appurtenances, unto the part y of the second part, his heirs and assigns forever, in fee simple. And the said part y of the first part, for his heirs, executors and administrators, doth hereby covenant and agree with the said part y of the second part, his heirs and assigns, that the said part y of the first part shall forever warrant and defend the title to the said premises, unto the part y of the second part, his heirs and assigns, against the claim of all persons lawfully claiming the same or any part thereof, except on account of taxes due from and after the 24th day of July A.D. 1873
