Dade Sub. of the County & State aforesaid for and in consideration of the sum of Sixteen hundred Dollars to me in hand paid by Gadwin Jones of the County of Pickens and State of Alabama hand and do hereby give grant sell and convey unto the said Gadwin Jones his heirs and assigns forever the certain tracts or lots or parcels of land following being the mid half of the North west quarter of Section Number Thirteen (13) Township Number Fourteen (14) North of Range Numbered Eighteen (18) East containing seventy and $\frac{62}{100}$ acres (and nine and $\frac{3}{100}$ acres off the mid edge of the East half of the North west quarter of the same Section Township & Range (unsurveyed) lying situated and being in the County of Noubeu and State of Mississippi land north eastern land District of said State at Columbus. Containing in all eighty acres more or less as numbered and known by the office maps of Survey of the United States of America. Together with all and singular the rights privileges tenements and appurtenances to every part and parcel thereof in anywise belonging. To have and to hold with and with my heirs and assigns forever and also all remainders or remainders and the rents issues & profits thereof and also all my right title interest claim and demand whatsoever in and to the same both in law and equity unto the said Gadwin Jones his heirs and assigns in fee simple absolute free and clear from all manner of incumbrances and load. now or to come as well as all other forever

And I do hereby bind myself my heirs Executors and administrators to warrant and forever defend the same and every part and parcel thereof unto the said Gadwin Jones his heirs or assigns forever against myself my heirs Executors and administrators and against every other person or persons lawfully claiming or to claim the same or any part or parcel thereof.
