## Campbell Co., Virginia Will Book 1, page 6 - (Transcript by Victor Hairston and Ed Bregenzer, 1997)

### Will of Samuel Hairston

In the name of God, Amen, I Samuel Hairston Gent, of the County of Campbell, being of sound mind, Do make and Ordain this my last Will and Testament, I lend to my well beloved Brother Andrew Hairston my whole Estate, real and Personal during his natural life and at his death I direct that my ? House where I now live together with one Thousand and sixty acres of land appertaining thereto may be sold by my Executors hereafter mentioned [blurred] who is hereby empowered to convey the same to the Purchaser or Purchasers in fee simple. And six Hundred pounds of the money arising from such sale to be equally divided between **my brother Robert Hairston's three sons, viz: George, Peter and Samuel Hairston** and the remainder of the money arising from such sale to be divided between **my brother Andrew Hairston's three daughters, viz: Priscilla, Margaret and Susanna Hairston**.

Item: after the death of my brother **Andrew Hairston** I give and bequeath to **Samuel Philips**, my negroe fellow named Jack to him his heirs and assign forever.<sup>1</sup>

Item: my tract of land at Kentucky containing two thousand acres I give and bequeath as follows, viz: Two Hundred acres to **Samuel Amos [Amyx], Two Hundred to his wife Eleanor Amos [Amyx]** and the remainder fourteen Hundred acres to be divided among my said **Brother Andrew Hairston's three daughters Priscilla, Margaret and Susanna**. I also give to the said Priscilla, Margaret and Susanna another tract of land at Kentucky containing three Hundred and eighteen acres to them their heirs and assign forever.<sup>2</sup>

Item: I give and bequeath to my **Brother Andrew Hairston's Daughter Priscilla** my negroe boy Davie to her and her heirs and assign forever.

Item: after all my just debts and funeral charges are paid I leave all the rest of Personal Estate of every kind together with my Negroe Back to my said Brothers three daughters **Priscilla**, **Margaret** and **Susanna** Hairston to them and their heirs and assigns forever. The negroe Back to remain in the possession of their Mother during her natural life and it is to be understood that the Legacies bequeathed the said **Priscilla**, **Margaret** and **Susanna** shall be divided in such manner that allow Margaret and Susanna shall have each as much money or land more than **Priscilla** as will be equal in value to the Negroe Boy Davie.

Lastly I constitute and appoint my Trusty friend **Robert Alexander** Executor of this my last will and testament, Ratifying and confirming this and no other. In witness whereof I have hereunto set my hand and seal this 9th day of February 1782.

### Schedule to the Will of Samuel Hairston, Gent, of Campbell County.

Item: my will and desire is that my Brother Robert Hairston's three sons **George**, **Peter** and **Samuel** have only one Hundred Pounds each out of my Estate and that the other Three Hundred Pounds which I had willed to them shall be divided as follows, viz: One Hundred Pounds to **my nephew Samuel Phillips**, fifty Pounds to **my niece Jane Phillips** and one Hundred and Fifty Pounds to be equally divided between my Brother Andrew Hairston's three daughters **Priscilla**, **Margaret** and **Susanna** and all my household furniture which is not sold to pay my debts and taxes shall be equally divided between the aforesaid **Priscilla**, **Margaret** and **Susanna** Hairston. In witness whereof I have hereunto set my hand and seal this sixteenth day of March One Thousand Seven Hundred and Eighty Two.

And at a court held for the said County the sixth day of June following the schedule to the said will was further proved by the oath of James Davison one of the witnesses thereto subscribed. And ordered to be recorded. And on the motion of Robert Alexander the Executor therein named who made oath thereto according to same certificate is granted giving security whereupon he together with John F. Patrick and John Hunter Gent. his securities entered and acknowledged their Bond in the Penalty of Two Thousand Pounds conditioned according to same for the said Executors due and faithful Administration of the said Decedents Estate and Performance of his will.

From Robert Alexander, Executor of Samuel Hairston, Gent., late of Campbell County, deceased, to Peter Hairston and Samuel

Hairston of Henry County, by authority of Samuel Hairston's will and for 400 pounds, Alexander sells to Peter Hairston and Samuel Hairston the following tracts of land in Campbell County on Beaver Creek and the branches thereof, one tract containing 310 acres bounded by the south side of the creek at a fine place for a mill. The other tract contains 550 acres bounded by his own corner heap of stones and pointers of the new patent on the line of the old patent, a black jack near the long mountain, thence across the spurs and the valleys of the mountain, the main road, the old mill place.

We the <u>?</u> appointed by the worshipful Court of Campbell at their November Term 1803 to settle the account current of the Estate of Samuel Hairston deceased with the executor and to divide and allot the Estate amount the Legatees. Report that we have carefully examined and compared the vouchers with the different charges exhibited in the account and find both from the information the Executor and vouchers provided that the account is just and right in balance appearing in favor of the Estate of three hundred and sixty three pounds thirteen shillings and five pence which included the interest on the four hundred pounds for which the 860 acres of the brick house land sold.

The interest on one hundred pounds of which is estimated 16 December 1803 as appears by the account also includes the interest on two bonds due to the Estate in 1782, one for thirteen pounds and one for nine pounds which bonds are now in the hand of the Executor. Also includes four pounds seven shillings and eleven pence which sum **Samuel Phillips and Jane Jackson [Hays] late Jane Phillips** have received more than their just portion and are dividing and allotting the

To **Margaret Hairston** the sum of sixty four pounds fourteen shillings and two pence half penny and to **Sally Hairston infant daughter Susanna** the sum of sixty four pounds fourteen shillings and two pence half penny making in all now due the said **David**, **Margaret and Sally** the sum of one hundred and sixty four pounds and two shillings and eight pence.

To **Samuel Phillips and Jane Jackson [Hays] late Jane Phillips** the sum of one hundred and ninety seven pounds seventeen shillings and eleven pence and it appears they have received the sum of two hundred and two pounds five shillings and three pence which is four pounds seven shillings and eleven pence more than their due. We also deem in one up any to rework that from information of the Executor there is a suit or suits yet despairing and undetermined all which is respectfully submitted given under our hands this **7 day of June 1804**.

## **GENEALOGY NOTES:**

- 1. Nephew The New and Complete Dictionary of the English Language published in 1775 states "The son of a brother or sister; a descendant, a grandson, but this sense has now grown obsolete".
- In his will, Samuel Hairston leaves a tract of land he describes as "my tract of land at Kentucky containing two thousand acres". Kentucky County, Virginia was established in 1777 from Fincastle County, which was formed from Botetourt in 1772. However, in 1780 Kentucky County was dissolved and three smaller Virginia counties were formed: Fayette, Jefferson and Lincoln. George Hairston, Samuel's nephew, was granted a land warrant for 2,000 acres in Jefferson County in 1786. These 3 counties were split again into smaller counties. During the 1780s these counties were further split into smaller counties until they were all transferred to Federal control in 1789.
