made and done this 16th of October 1829. between John G. Anderson, of the State of Tennessee and County of Hickman of the one part and Samuel Warston of the County of Allen, and State of Kentucky, of the other part Witnesses, that for and in Consideration of the sum of three hundred and seventy dollars to him the said John G. Anderson in hand paid by him said Saml. Warston, the receipt whereof him the said Anderson did give grant bargain, and sell to him the said Warston, a certain tract or parcel of land situate lying and being in the County of Barren and State of Kentucky on the waters of Glovers Creek, waters of big Barren River and bounded as follows Beginning on Wilsons Poplar Corner, thence North 81 West 74 poles, to a beech and black Gum on baldwells line thence South 5 East 160 poles with baldwells line to his corner two hickories & a poplar thence South 12 West 40 poles to a beech sugar tree and poplar thence South 19 East 80 poles to a red Oak and white Oak thence North 70 East, 100 poles to a white Oak and black Ash thence North 80 poles to a white Oak on Wilsons line, thence North 49 West with said line to the Beginning which Land, and premises the said Anderson doth Warrant and forever defend from him and his Heirs & assigns to him the said Warston, his Heirs and assigns forever, In Witness whereof him the said Anderson doth hereunto set his hand and affix his seal in presence of us.
