-ed as follows to wit) Beginning at Andrew Herstons corner
stone thence a straight line thirty four Poles to a corner shrub
white oak thence a straight line one hundred and sixty
Poles to Herstons corner white oak thence along his own line
to the first station, To have and to hold the said fifteen
akers of land more or less and all priviledges there unto belong-
-ing unto the said Archer Williamson his heirs and assigns
for ever to the only proprietor and behoof of the said Archer

This Indenture made this fourteenth day of October in the
year of our Lord one thousand seven hundred and ninety nine
Between James Carson of the County of Campbell of the one Part and
his son Thomas Carson of the same County of the other Part. Witnesseth
that he the said James Carson for and in consideration of the sum of five
hundred Dollars current money to him in hand paid the Receipt of which
he doth hereby acknowledge hath granted bargained and sold and by
these Presents doth grant bargain sell enfeoff and confirm unto the
s-d Thomas Carson his heirs and assigns for ever one certain tract or par-
-cel of land situated in the County of Campbell on both sides of
back run and Prince Edward road it being part of four hundred
acres purchased by the s-d James Carson of Thomas Bowling of Ches-
-terfield County which was Part of Bowlings Pilot Mountain Tract
containing two hundred acres more or less and bounded as follows
(to wit) Beginning at  white oak a corner of the Patent lines
thence a Dividing line West crossing back run and Prince Edward
road and up a branch and out of the head of the same 120 Poles to
Pointers on the line of the 400 acres aforesaid thence along the lines
of the same S 12° E 220 Poles to corner Pointers and S 70° E crossing back
run and rocky branch 50 Poles to a sorrel on the patent lines thence

along
