 John Burnett James Faralca and others unto the said Washington Rowland
 Trustee as foresaid to him his heirs forever to have & to hold the said Land
 unto him the said Washington Rowland Trustee &c but it is Expressly under
 stood by the Parties aforesaid that the Land aforesaid granted unto
 The said Washington Rowland Trustee upon the special Trust & Confidence
 Reposed in him by the said George & Harden Hairston Now the said Wash
